

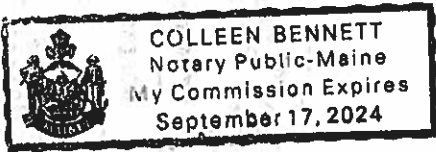

To Whom it May Concern,




It is our request that an election official review the ballots for Nov. 6, 2018 in the Boothbay Region, especially in Boothbay, where the most Poliquin voting occurred.
